Reduced Daycare Fees for 2017-2018

Reduced daycare fees are available to families who do not receive financial support from their employer towards daycare fees. Reduced fees for 2017-2018 are the following:

Nursery (1-4 years old)	€ 2 900
Preschool (5*-7 years old)	€ 3 190

**The children who are 5by 1st of September 2016 are admitted to Preschool group.*

The fee can be paid:

- in one full payment (due 1 September)
- in two equal instalments (in September and in January)
- in 10 equal instalments.

Included in Annual Fee

- Books and workbooks
- Art supplies
- High-quality care and educational programme
- Transport to field trips

Not included in Annual Fee

- Daycare lunch and snack
- Clubs offered by the daycare teachers
- Judo club led by a Sport's Club Do teacher
- Enrolment fee (32 Eur)
- Trips, extra programmes outside the daycare (visit to the theatre, cinema)

Tuition contract

The tuition contract is an agreement between a student's representative and the daycare. Parents are requested to sign tuition contract within ten days from the date issued, thus completing the enrolment procedure. The tuition contract determines the rights and obligations of the parties, states the tuition fees and due dates.

Payments

All fees are payable in euro on or before the date specified on the invoice to:

Transfers from foreign countries are accepted. Incurred bank charges are to be paid by the depositor.

Early withdrawals

When the student has been enrolled but will not attend, written cancellation is required from the parents prior 1 August. This cancellation will omit the obligation of paying of the tuition fees.

A written notification 30 days prior departure is required from the parents in case the student is withdrawn early.

Refunding the balance of the tuition fee on the premature termination of the Contract, shall take place as follows:

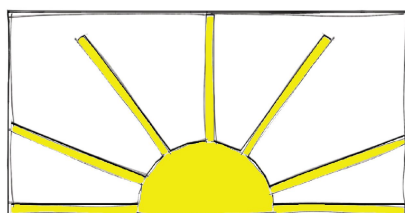

Corporate Daycare Fees for 2017-2018

Corporate Tuition Fee is payable by parents (or their corporate sponsors) receiving financial support for daycare fees.

Nursery (1-4 years old)	€ 6 270
Preschoolers (5*-7 years old)	€ 6 875

**If a child is 5 years old on the 1st of September, when starting the new academic year, he or she will be regarded as a preschooler.*

- High quality care and educational program (5 days per week, from 8 - 17:30)
- Books and workbooks
- Art supplies
- Lunch and snack
- All clubs offered by the daycare teachers
- Judo Club led by Sport's Club Do
- Additional Pre-school program twice a week (for pre-schoolers)
- Trips

Not included in Annual Fee

- Enrolment fee
- Lessons that exceed the curriculum

Enrolment fee

The enrolment fee is one-time non-refundable fee charged the first year a child attends TIS. The date the fee is received determines the order of enrolment.

Tuition contract
